- **3. MINUTES:** To consider the approval of the Minutes of the meeting held Thursday 10th July 25. The minutes were accepted as a true record of the meeting. All in agreement.
- 4. COUNTY COUNCILLORS REPORT. Cllr Roger Bennett spoke about Unitary councils. At the last meeting at WWC all local councils apart from one wanted two unitary councils with a north south divide. This will continue to be discussed until the end of October and a report sent to central government who will decide. It is thought one unitary council rather than two will save around £5,000,000. Only 1% of the electorate in Worcestershire responded to the public survey on Unitary Councils. It is thought this was due to confusion from government. Eventually the three shire councils will combine and led by a mayor. It is said there will be 6,000 residents to one Councillor. Cllr Eacock said she had asked the Healthy Worcestershire Grants officer to contact the clerk about events paid for by the County Council.
- **5. BOROUGH COUNCILLORS REPORT.** Cllr Brandon Clayton reported Redditch will have its final meeting along with the other 5 Districts. At present four councils prefer two unitary councils and two councils prefer one unitary council. It was commented these arrangements and changes are costly to the taxpayer. The secretary of state will have the final decision but has said no decisions will be made until June 2026. In 2027 there will be elections for a shadow cabinet. In April 2028 Worcestershire County Council, Borough and District councils will disappear. The shadow councillors will then become "real."

Cllr Chris Hoyz advised PCSO's will no longer work beyond 8pm. The Borough Councillors have raised objections. These changes do not apply to response officers or neighbourhood officers.

Cllr Hoyz asked if the Borough council owned the allotments in Feckenham as in some Redditch areas there may be plans to sell the land for housing. This would not affect Feckenham as the Borough Council do not own the land.

The end of September is the cutoff date for developers to express their interest in potential land for new homes. Redditch should hear the outcome as where these areas will be found in Redditch.

9. NEW AGENDA ITEMS

- a. **Project Gigabit. Project Gigabit** is the UK Government's £5 billion national broadband programme run by Building Digital UK (BDUK), part of the Department for Science, Innovation and Technology. Its purpose is to extend gigabit-capable broadband (1,000 Mbps) to hard-to-reach homes and businesses that will not be served by commercial rollouts alone. The PC received a thorough presentation and will look to explain this in detail to the parish.
- **b. Planning Proposal to ask for professional help on strengthening planning comments in view of Government increase of housing targets.** Postponed from July meeting. The parish council agreed to engage the services of Urban Vision Enterprise and work with Hannah Barter. Their expertise will help strengthen any planning objections or approvals the parish wish to make. The PC may need to register with the Borough Council for a neighbourhood plan.
- **c.** Housing Needs Assessment. After discussion, the PC agreed to appointing Community First to conduct a housing needs assessment. Rebecca Seignior, Rural Housing Enabler will be helping the parish council to find out whether the parish is opposed to new developments or in favour in specific locations and what or how this would work in the Parish. It is especially important parishioners tell the parish council their opinions.

- **f. Ongoing arrangements with FABBS.** The PC agreed to write to FABBS Chair to request copies of minutes on a regular basis.
- **g. Feckenham Football Club.** The parish council are pleased to announce Feckenham football club are hosting the Unity sports club CIC. This is an organisation specialising in sport for young children. They will play a maximum of two games on Saturday mornings and one game fortnightly on Sundays.
