**1. APOLOGIES: Cllr Paul Downes, Cllr Chris Holz (RBC) and Cllr Roger Bennett.**

#### **2. DECLARATIONS OF INTEREST AND DISPENSATIONS:**

b) To receive written requests for dispensations for disclosable pecuniary and nonpecuniary interests (S33 of the Localism Act 2011) which are to be with the clerk as soon as possible prior to a meeting. Cllr Alan Smith, Cllr Ian Bellion, and Cllr Erica Guise. All said they would not speak regarding 9C as they are members of the Wake committee.

#### **c) TO CONSIDER GRANTING REQUESTS FOR DISPENSATION**

Requests for dispensation must be made on an individual basis. Cllr Barrett-meade and Cllr Rob Oaten said they were neighbours of 7a. It was accepted they would speak but would abstain from voting.

**3. MINUTES:** To consider the approval of the Minutes of the meeting held Thursday 15<sup>th</sup> January 2026. The minutes were approved as a true representative of the meeting

**4. COUNTY COUNCILLORS REPORT.** Cllr Eacock asked for the latest update on flooding and was advised the next meeting is 6<sup>th</sup> March. The County Council have applied to raise Council tax above the 5% maximum. Government will make the decision. Unitary Authorities decision has now been pushed back to June.

**5. BOROUGH COUNCILLORS REPORT.** The Borough Councillors said Redditch is one of twenty-nine councils who have elected to postpone May 2026 elections. Next year WCC will hold shadow elections. This is to ensure the unitary councils will be in place when Borough and District councils cease to exist in 2028. The secretary of state has approved the plan.

The new local plan is still in development. The call for sites suggested 5200 new homes could be built in and around Redditch. However, Redditch will still be under target by 3,000 new homes. The Borough Council may try to readvertise, and the PC were advised under current rulings, developers can reapply. It is unlikely planning officers can refuse the applications. RBC can ask other areas if they can build in their area. Neighbouring areas have a duty to comply. Land does not need to be developed for nine ½ years after the most recent Neighbourhood plan is produced and adopted. The new plan will be sent and shared with WCC. Webheath is likely due to be further developed which could increase flooding down to Feckenham.

## 8. FINANCE

## 9. NEW AGENDA ITEMS

- a. **Police have arranged a community meeting Sunday 1st March.** Does the PC wish to pay the village hall costs. The PC agreed to fund the village hall costs. The date has changed to 21<sup>st</sup> March and will be primarily offering parishioners home security advice.
- b. **Tree blocking the flow of Bow Brook.** The clerk said the Environment Agency assessed the tree, and do not feel it justifies their input it at this time. The EA suggested speaking to the landowner.
- c. **Grant application from Feckenham Wake.** The PC agreed to support Feckenham Wake and agreed to award a grant payment of £1,000.
- d. **Jislon Satellite and Milestone Islands. To consider improving visibility of the satellites due to discolouration.** The Council agreed the satellites need to be more visible. It was suggested asking WCC if they had any thoughts and to ask the original company for an estimate of new satellites.
- e. **Speed reduction on Astwood Lane and Droitwich Road.** The PC agreed speeding is still an issue within the village. The clerk will approach Safer Roads for help and speak with the local policing team.
- f. **To consider the revised IT policy to reflect Assertion 10 guidance.** The PC agreed to adopt the updated policy.
- g. **In line with assertion ten to adopt GDPR within Council activities.** The PC agreed to adopt the updated policy.

## 11. PROGRESS REPORTS

- a) **Flood works and Highways.** The next meeting has been arranged for Friday 6<sup>th</sup> March, and it is hoped there will be more funding news mid-March.
- b) **Parish Neighbourhood Plan.** The PC has asked the planning department to consider adding Feckenham as a separate page to the New Local Plan using the report commissioned by the PC which has been sent. A decision is awaited.
- c) **Housing Needs Survey.**  
The housing needs survey has been analysed, and the results have been fed into the Parish Neighbourhood plan. This will be available on the parish website.
- d) **To open a higher interest account.**  
This will be done as soon as time allows.
- e) **Initial discussion on potential Community Project at the Winfield's site.**  
There was an introductory meeting arranged for Thursday 5<sup>th</sup> Feb at 7pm. The PC agreed to arrange a parish meeting purely to give the village a chance to come together, discuss and exchange details with the current owner. The PC is only arranging the original meeting and is not involved in any commercial activity with either Winfield's or any other parties. It must be noted this is a commercial arrangement and anyone/organisation is urged to seek legal advice.
- f) **WCC Highways- Planning Department to request HGV's and other large vehicles do not use the High Street for access.**  
The PC have asked for the Highways planning Team to attend the next Highways / Flood meeting.
- g) **Website specific page on BESS /Solar information.**  
The website developer has been asked to create a separate page.
- h) **Website specific page for FVAT (Feckenham Village Amenity Trust).**
- i) The website developer has been asked to create a separate page.
- j) **Volunteer Parish Path Warden.** Still vacant.
- k) **Project Gigabit.** Cllr Oaten to attend a meeting 10<sup>th</sup> February and will draft a report for Feckenham news and the PC.
- l) **Healthy Worcestershire.** Cllr Eacock has reminded WCC that Feckenham needs to be included and asked for the community transport to include the parish.

m) **Unitary Authority.**

The consultation, which was launched on 5<sup>th</sup> February, will run until 26<sup>th</sup> March and we currently expect the final decision on the preferred proposal in July.
